SIL Lead participated in a language development project in Uganda funded by USAID, as a subcontractor to RTI International. This five year USAID project was implemented to support Uganda's Ministry of Education and Sports to improve the quality of education in Uganda emphasizing early grade reading and HIV and AIDS education. SIL LEAD consultants have led the development of instructional materials in all of the 12 program languages, provided technical support for training of trainers and teacher training workshops, as well as continued to support the process of orthography development for several languages.

4b (Code:) (Expenses \$ 97,894 including grants of \$ 0) (Revenue \$ 0)

SIL Lead participated in a language development project in Ethiopia funded by USAID, as a subcontractor to RTI International. The main objective of the READ TA project is to improve the reading and writing performance of 15 million primary grade students in seven Ethiopian languages, and English as a second language. This five year country-wide USAID project is currently in its fourth year of implementation. SIL LEAD has reviewed national mother tongue curriculum and has assessed the existing learning materials for three languages-Wolayttatto, Hadiyyisa, and Sidaamu Afoo. Teaching and learning materials have also been prepared for grades 1-8 in three languages. SIL LEAD is currently supporting the ongoing English as a Second Language (ESL) curriculum and material revision and development efforts.

4c (Code:) (Expenses \$ 93,355 including grants of \$ 0) (Revenue \$ 0)

SIL Lead participated in a language development project in Nepal funded by USAID, as a subcontractor to RTI International. USAID's Early Grade Reading Program (EGRP) is a five year project to support the Ministry of Education in Nepal with the overall goal of improving reading outcomes in Nepali and three mother tongue languages, Rana Tharu, Maithili, and Awadhi, for over one million learners. SIL LEAD will provide short term technical assistance to the program through curriculum and material development for three mother tongue languages to support the Government of Nepal's National Early Grade Reading Program (NEGRP). In addition, SIL LEAD will provide technical assistance through supplementary materials development, teacher training and building the capacity of local NGOs. Grade 1 student books and teacher guides for Rana Tharu and Nepali as a second language (L2) will be ready to print by February 2016.
